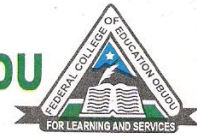

## EXPRESSION OF INTEREST (EOI)

The Federal College of Education, Obudu, Cross River State, invites expression of interests from competent and qualified/Licensed Auctioneers to carry out a public auction of some unserviceable vehicles and plants.

### GENERAL CONDITIONS:

#### Interested applicants are expected to show evidence of the following:

- a. Evidence of Registration with Corporate Affairs Commission (CAC)
- b. License as a Federal Auctioneer
- c. Evidence of current Tax Clearance Certificate for the last three (3) years (2016,2017 and 2018)
- d. Evidence of VAT certificate and VAT Remittance to Federal Inland Revenue Services (FIRS)
- e. Pension Clearance Certificate issued by PENCOM valid for 2018 in compliance with Pension ACT 2004
- f. Industrial Training Fund (ITF) Certificate valid for 2018 in compliance with Industrial Training Fund Amendment Act 2011.
- g. Evidence of Registration with National Social Insurance Trust Fund (NSITF)
- h. Evidence of Registration with Bureau of Public Procurement (BPP) Federal contractors, Consultant and Suppliers Database.
- i. Evidence of financial capability
- j. Sworn affidavit that:
  - (i) The firm is not bankrupt
  - (ii) None of the Directors is an ex-convict or bankrupt and
  - (iii) No member of the Boarding Committee or Management Committee is a former or present director, shareholder or has any pecuniary interest in the bidder
  - (iv) All information presented in the bid is true and correct in all material particulars.

### SPECIFIC CONDITIONS:

#### TERMS OF REFERENCE (TOR)

- (a) Terms and Conditions of carrying out the auction in line with the provisions of the Public Procurement Acts 2007.
- (b) The schedules of implementation and expected outputs.
- (c) The terms of remuneration for the services.
- (d) The responsibilities of Federal College of Education, Obudu and those of the auctioneer.
- (e) All other important elements considered relevant and necessary for the auction exercise.
